

**Looking back the past year,**  
**NRN Australia, 2007**

**From the President.**

As many of us would remember that the NRNA ICC had given birth to its Australia chapter in 2005. A very wide effort was made to involve all the Nepalese individuals and organisations in this theme. As a result, we had very successful Second NRN National Conference in Sydney on 7 July 2007. In the representation process for National Coordination Committee, as much as we tried to involve all streams of the community, we did not leave any untouched corners to remain very close to the heart of our own theme; first of all, we all are Nepalese. That has always worked. We wanted our Australian Chapter of NRN Network to be most representative in its structure, views and activities by inviting all states, social streams, all organisations and individuals. We had enormous response to this theme from the true believers. As a result, there is a wide support and enthusiasm from the public to the NRN theme.

Contribution to the philanthropic projects in Nepal, advocacy in favour of the NRN Bill and NRN rights, connecting NRNs, flood victims donations and other public awareness campaigns were some of the activities NRN Australia has been able to accomplish during the last year. There is a long way to go. The team was very cohesive and some members have put tremendous time and effort in accomplishing the NRN Australia activities. All NRNs have always been of tremendous support to carry out its activities. Business community, community organisations, social leaders, intellectual community, all individual NRNs, Nepal consulate, Nepali Embassy Canberra and other stakeholders in Nepal, are just a few names that have encouraged us in supporting the NRN Australia cause over the past one year. I truly believe this will foster, as it develops to give full coverage to all Nepalis residing globally and in any given country.

The Nepali Parliament passed NRN Act and NRN Rules are expected to be released by the end of January 2008, which was the greatest achievement of NRNA ICC globally. Some of the highlights of the NRN Act are 10 years visa for People of Nepali Origin (PNO) /who hold a foreign passport will be able to enjoy the privileges of inherited property to keep in his/her name. They will be able to purchase land for residential housing and unrestricted business rights similar to Nepali people residing in Nepal.

Now we are formally recognised and have got the NRN status back in Nepal. These were the outcome of our united voice, which has created pressure groups and has lobbied Nepal Government to prioritize in executing the NRN Act.

The successful outcome of the third global conference of NRN ICC was the positive signal from the all-political parties, community members for dual citizenship.

The chief guest and the honourable Prime Minister Mr. Girija Prasad Koirala initially spoke as a representative of the NRN community and later as a PM. As a NRN

representative, he advocated the Government to award dual citizenship to the NRNs which generated a big round of applause from the audience. Prime Minister assured his full support and expressed his full commitment towards helping NRNs.

- ❖ February 2007 - Released 200 Nepal Festival 2006 DVDs.
- ❖ February 2007 – Published Preliminary Feasibility Study Report on the Construction and Operation of Nepali Community Centre in Sydney.

- ❖ June 2007 -Donated US\$1,000.00 to NRN Devghat Briddhashram Project Nepal
- ❖ July 2007 - staged Second Bi Annual National Conference represented by all walks and patterns from NRN Global and NRN Australia families.

- ❖ July 2007 - NRN Australia formally recognised the outstanding performers and/or achievers in the Nepalese Community under several different categories.
- ❖ August 2007 - Prepared Second National Conference report which can be viewed in NRN Australia website.
- ❖ August 2007 - Prepared discussion paper on how to accommodate interested NRNs in to NRN activities for the next two years which was approved by the NRN Executive meeting held on 12 August 2007 at Pacific College of Technology. We forwarded it to NRN registered members for their expression of interest to get involved.
- ❖ August 2007 - formed a committee to prepare a skill database of Nepalese people residing in Australia “**Who is who in Australia**”.
- ❖ August 2007 - formed a committee to investigate how we can do a video or tele- conferencing of NRN Australia across Australia in order to get active involvement and interaction within all states.
- ❖ August 2007 - organised an interaction program on NRN Act addressed by the following high level delegates from Nepal Government
  - Mr. Suresh Prasad Pradhan Joint Secretary Ministry of Foreign Affairs.
  - Mr. Suresh Man Shrestha Joint Secretary of Ministry of General Administration
  - Dr Badri Pokharel, Ministry of Finance
  - Mr. Umakanta Parajuli, Ministry of Foreign Affairs
- August 2007 – collected donation on behalf of NRN to Nepalese world cyclist **Mr. Dhakeshewar Chetri** over \$500.00
- September 2007 - Prepared country profile of NRNs Australia for NRN Third Global Conference which was held on 15 to 17 October 2007 in Kathmandu “
- ❖ September 2007 - prepared a fact sheet on “ Before deciding to come Australia for study, you should review and reconsider the following issues” which was circulated to members for their comments. After the consultation of the stakeholders, it will be posted through our websites and will be forwarded to Nepal
- ❖ September 2007 - released an official appeal to Nepalese community residing in Australia for the contribution of Flood Relief Fund, which was sent to NRN ICC Kathmandu. Total collected to date was A\$ 3,212.50 and NRs 200,000
- ❖ September 2007 - Helped Sunrise Club for Fund raising programme to help Nepal, which was organised in Sydney.
- ❖ September 2007, NRN Australia forwarded a 15 Pages comments and suggestions on the Revised NRNA ICC Constitution.
- ❖ September 2007 Contributed Approx. \$2,000 NRN membership fees to ICC Kathmandu
- ❖ September 2007 - NRN Australia has sought an Expression of Interest from Nepali Community Businesses for Membership privileges “ **NRN Australia and Nepali Community Business Partnership Programs**”
- ❖ September 2007 - organised an interaction program on NRN Act with the high level visiting delegates from Nepal Government, that included:
  - Mr. Gyan Chandra Acharya Foreign Secretary
  - Mr. Shanker Bairagi Charge D’affaires Nepali Embassy Canberra
- ❖ October 2007 - collected expression of interest to attend the third Global conference, which will was held on 15 to 17 October 2007.

- ❖ October 2007 – NRN Australia team participated in the Third Global Conference, which was held on 15-17 October 2007 in Kathmandu (over 25 people from Australia). The following Australian representatives to the Third Global Conference contributed the following during the third global conference, which was seen as one of the well-united teams amongst others from more than 40 countries.

- ❖ **400,000.00 rupees contributed to Jiri Multipurpose High School, Jiri, Dolakha District for the construction of conference hall as a part of one**

**district one project programme of NRNA (contributed by Mr. Deepak Khadka, NRN ICC member, Australia). Which was NRN Australia one district one-project programme.**
